Dear Mr. President:

Why is Myron C. Taylor still allowed to remain at the Vatican from the United States? The late President Roosevelt claims he sent Taylor as his personal Representative, but the official paper of the Vatican, also high officials of the Pope stated plainly that he was recognized as an official Ambassador from the U.S.A. Now that you are President, why is Myron C. Taylor not recalled? Or do you intend to name a Successor to Him?

Mr. President, this is a Protestant Nation and the Roman Catholics only comprise one-fifth of the population so why should this nation have an Ambassador at the Vatican? The Catholics only comprise about one-fifth of the population but for the last twelve years they seem to get all the high appointed offices and numerous other jobs through the New Deal. The majority of Republicans appointed to any important positions were mostly Catholics, as note: Wild Bill Donovan from Buffalo, also Stettinius, former Secretary of State, Former Attorney General Biddle, and numerous others including Post Master Generals for the past twelve years. Also regarding our foreign affairs with Spain, Russia, etc. It seems that one Jimmie Dunn has powerful influence in the State Dept. in Cordell Hull's Cabinet, also Stettinius, and now with James F. Byrnes. From reliable sources Jimmie Dunn was alleged to have prevented food, medical and military supplies from going to the late Spanish Republic which had millions of dollars in gold in banks in New York City. But as soon as Bloody France with the aid of Hitler, Mussolini and the bloody savages from Morocco defeated the Loyalists of Spain then Jimmie Dunn gave his O.K. for all the wheat, food, medical supplies, etc. originally intended for the Loyalists to be shipped to France. Why was this allowed?

Millions of AMERICANS would still like to know. Also when Stettinius was Sect'y of State, he took Jimmie Dunn to the Peace Conference at San Francisco, and Dunn is alleged to have continually interfered and opposed Russia at the Peace Table in Frisco. Who is back of Dunn? Is it Arch-Bishop Spellman who has such powerful influence at both the White House and State Dept.? The late President Roosevelt appointed him General of the Chaplains in the late war, a title never before bestowed on any Priest, Preacher or Rabbi in the history of this Country. Also the late President Roosevelt is alleged to have asked Stalin at one of the Big Three Conferences to allow the Pope or his Representative to sit at the Peace Table after the surrender of the Nazis and Japs. Yet the Pope had the Audacity and Gall a few days after the Japs sneak Attack on Pearl Harbor---Get that---after Pearl Harbor. The Vatican and Japan exchanged Ambassadors to represent each power in Rome and Tokyo clearly showing the Pope's contempt for the U.S.A. And yet the Pope claims to be Christ's true and only Vice-Regent on earth. So I am asking you again why Myron C. Taylor should not be recalled from the Vatican City and no Successor either in the Guise of your Personal Representative or as an Official Ambassador.
